- 1. **COMING EVENTS:**
- a) Plain English Speaking Awards. NSW State finals Friday 28 July 9.30am to 12.00pm NSW Teachers Federation Conference Centre, 37 Reservoir Street, Surry Hills.

This annual event, organised by the NSW Department of Education, brings together six of the State finalists from schools throughout NSW to compete for the State PESA award and who will then compete in the National finals. The Australian winner will compete in an International competition in London. This event is supported by our Society with \$100 encouragement awards to each finalist and \$250 to the State winner. One of these participants may be invited to replicate his or her address at the 2018 Queen's Birthday dinner.

If you wish to enjoy a series of witty, intelligent, well-structured arguments, and the best of our wonderful English language, consider spending the morning with us. No bookings are necessary and the venue is a short walk from Central railway station.

b) Last Night of the Proms Saturday night 19 August 7.00pm, Sunday afternoon 20 August 2.00pm. Chatswood Concourse, tickets \$47.00.

c) Luncheon Thursday 7 September, Noon until 3.00pm Union, University and Schools Club (UUSC), Bent Street Sydney. Guest of Honour: Hon Tim Fischer AC, retired former Leader of the National Party and Deputy Prime Minister, addressing the life of our most famous General Monash and the case for him to be elevated to the rank of Field Marshal

Tim Fischer is one of our most admired retired politicians and later, Australian Ambassador to the Holy See. He is an active advocate of the deserved elevation in ranking of our greatest General to that of Field

Marshal. This address by Tim Fischer is an important exposé on one of Australia's greatest sons, not only in military struggles at Gallipoli and the European theatre of World War I, but in later civic roles in Victoria. Whilst he was the only General knighted in the field by King George V, the question arises as to why such a commander was overlooked for the ultimate military rank of recognition. Tim Fischer will add to these questions and others that you may have at the end of his address. A flyer will issue closer to the date, however we encourage you to join us for a special occasion.
