## **1. FORTHCOMING EVENTS**

#### **Wills and Legacies:**

Recently, the Society benefited by receiving a legacy from the estate of a late member, who had included such a gift in his will. This legacy has been a wonderful boost to the Society's grants scheme for young Australians, and was much appreciated. In addition, we have recently had an enquiry from a law firm acting for a member who was in the process of updating their will as to the appropriate wording for a clause to include in it.

I invite you to consider this in relation to your own personal arrangements. Should you be amenable to adding a clause to your will, the appropriate wording to provide to your lawyer is:-

“a) I give ..... dollars (\$.....) to the Australia-Britain Society (NSW Branch) Incorporated, ABN 75 368 639 375.

b) If at my death the Australia-Britain Society (NSW Branch) Incorporated has ceased to exist or has amalgamated with another organisation or has changed its name this gift shall not fail but shall be construed as a gift to any such replacement entity or such entity which my executors consider most nearly fulfils the objects that I intend to benefit.

c) I direct that the receipt of the Treasurer or Secretary for the time being of the Australia-Britain Society (NSW Branch) Incorporated or any replacement thereof shall be a sufficient discharge to my executors.”
